To Report A Violation(s) or if you have any questions please call Crow Tribe Fish and Game (406)679-0337. Permits are available for purchase Monday through Friday 9am-4pm at the Crow Tribe Fish and Game Department located at 43 Heritage Road, Crow Nation Express Gas Station located in Crow Agency, MT, and Yellowtail Market, Ft. Smith, MT.
