2) My Absentee Ballots must be mailed to the Office of the Tribal Secretary at the special Post Office Box shown above and on the outside envelopes for the Absentee Ballots.

3) My Absentee Ballots must be actually received at the special Post Office Box **on or before the Primary Election Day and the General Election Day**. Any Absentee Ballot not received by the applicable Election Day will not be counted.

4) It is my responsibility to find out who are the certified candidates for each of the Primary and General Elections – from the Notices published by the Office of the Secretary – and to write in the names of certified candidates on my Absentee Ballots. **Only votes for certified candidates will be counted.**
