# 2020 Miss Crow Nation Pageant



## GENERAL INFORMATION:

**Miss Crow Nation Contestants must be 16 years old to 25 years old.**

Applications are due by Friday, October 4<sup>th</sup>, 2019 at 4:00 p.m.

Applications can be submitted by the following:

**The Pageant will begin at 2:00 P.M. on October 6<sup>th</sup>, 2019.**

There will be a meeting with the Pageant Coordinators and Contestants prior to the Pageant at Noon at the Billings Depot. Contestants will have a dressing area at the Billings Depot to change into Crow Regalia.

Contestants will be judged on the following:

1. Dancing - depending on the number of candidates: Two (2) starts of each song (Coordinators will make adjustments if needed)
  - Straight Song
  - Double Beat
  - Round Dance
  - Push Dance (Contestants may make prior arrangements in choosing a partner)
2. Question and Answer
  - What does the title Miss Crow Nation mean to you and how will you represent as Miss Crow Nation?
  - Each contestant will be asked one random question.
3. Cultural Presentation of your choosing (Maximum time limit of 5 minutes)
4. Regalia (done by the panel of Judges throughout the competition)
5. Poise (done by the panel of Judges throughout the competition)

## **Expectations**

1. Miss Crow Nation must represent the 2020 Crow Fair and Apsaalooke Nation; whenever, she is called upon to do so. The events may include, but not limited to, parades, powwows, conferences, banquets, tourism events, Crow tribal events, etc. If for some extenuating circumstance a Miss Crow Nation is unable to perform the duty required of her, she will immediately notify the Crow Fair Manager.
2. It is very important for Miss Crow Nation to maintain certain moral standards for herself. It is mandatory that Miss Crow Nation conduct herself above and beyond reproach. This also means that you will refrain from the use of alcohol, drugs, smoking.
3. Miss Crow Nation will serve as a positive role model and will refrain from any activities and behavior that may be deemed unbecoming of the title.
4. Miss Crow Nation will participate in all grand entries and parades during Crow Native Days and Crow Fair 2020 as well as other local powwows.
5. Miss Crow Nation will refrain from posting, on social media, negative status updates, provocative pictures, etc. during her reign.
6. Miss Crow Nation will sign a 'Contract Agreement' that will outline the expectations and duties for that upcoming year as a titleholder.
7. Miss Crow Nation must wear Crow Style regalia when representing her title during the various events required.
